Forms Library

Access a vast library of forms from the USCIS, DHS, DOJ, DOL, ETA, EOIR, DOS and California Judicial Council. Forms are updated regularly, and can be saved, printed, emailed, and spell checked.

Case & Forms Management

Create cases, auto-populate forms, attach documents, create reminders, comments, checklists, custom fields and more.

Contact Management

Create and manage individual clients, maintain relationships between clients, track document expiration dates, add comments, and more.

Reports Management

Case Initiation Request

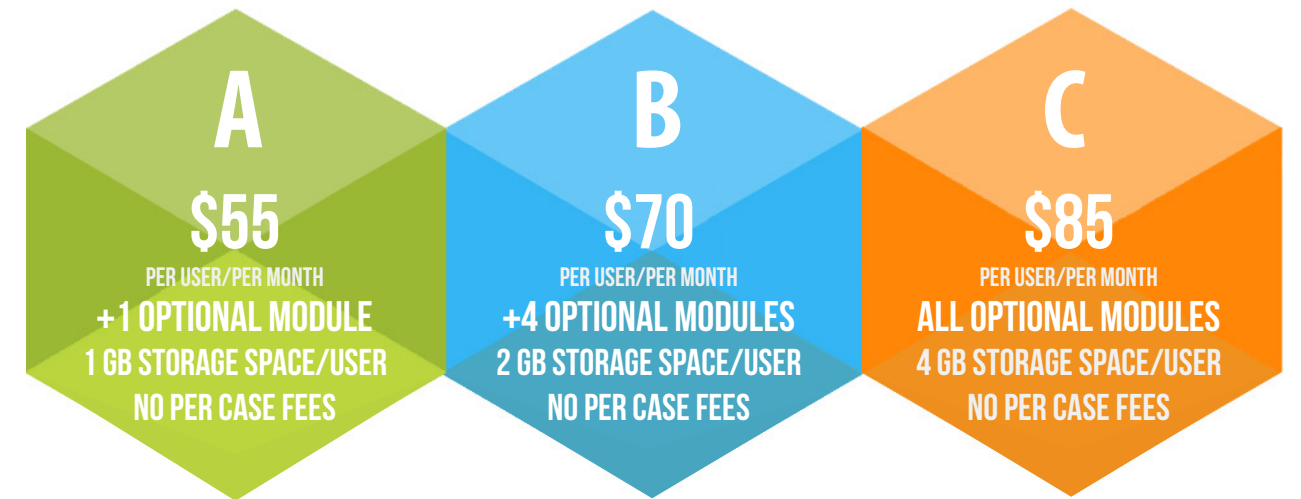
Case Initiation Requests allow employers or representatives of an employer to initiate cases for employees.
